## New Glarus Historical Preservation Commission Meeting Minutes 07-10-2023

- 1. <u>Call to Order</u> The meeting was called to order at 6:31 pm.
- 2. <u>Appointment of Chair</u> By consensus, no Chair was appointed.
- 3. <u>Approval of Agenda</u> Larry moved and Tim seconded to approve the published agenda. Passed 5-0
- <u>Approval of 4.13.23 Minutes</u> Kim moved and Larry seconded to approve the 4-13-23 minutes. Passed 5-0
- 5. <u>Consideration/Discussion</u>: Chalet of the Golden Fleece Sandy stated that the Chalet's Exterior is currently being painted by Coplien. She has also written a grant for \$10,000 to the Community Foundation of Southern Wisconsin. This grant would pay for the restoration of the ornately decorated/painted cast iron chest.
