SECOND STREET RECONSTRUCTION-SIXTH AVENUE TO TENTH AVENUE

The Village of New Glarus will receive sealed Bids for Second Street Reconstruction-Sixth Avenue to Tenth Avenue until 11 A.M. Local Time, January 18, 2008 at the New Glarus Village Hall, 319 Second Street, New Glarus, Wisconsin 53574 at which time the Bids will be publicly opened and read aloud.

The Work includes the construction of 3,100 linear feet of concrete curb and gutter; 4,700 tons of dense graded base; 1,500 linear feet of sanitary sewer; 1,700 linear feet of storm sewer; 2,850 cubic yards of common excavation; restoration, appurtenances, and miscellaneous items.

Bids are to be addressed to the Village of New Glarus, 319 Second Street, New Glarus, Wisconsin 53574 and shall be marked "Sealed Bid-Second Street Reconstruction-Sixth Avenue to Tenth Avenue, Contract 2-2008."

Bidding Documents may be obtained from the Issuing Office which is Strand Associates, Inc., 910 West Wingra Drive, Madison, Wisconsin 53715. A deposit of \$100 will be required. Overnight mailing of Bidding Documents will not be provided. The deposit will be refunded if the Bidding Documents are returned in good condition no later than thirty days after the day set for receiving Bids. A non-refundable handling fee of \$25 (separate check) will be required for ALL requests for Bidding Documents.

Bidders who submit a Bid must be Plan Holder of record at the Issuing Office. Bids from Bidders who are not on the Plan Holders List may be returned as not being responsive.

Plan Holders are requested to provide an e-mail address if they wish to receive addenda and other information electronically. Plan Holders are requested to designate whether they are a prime contractor, subcontractor, or supplier if they want this information posted on the project Plan Holders List.

No Bid will be received unless accompanied by a cashier's, certified or bank check or a Bid Bond equal to at least 10 percent of the maximum Bid, payable to the OWNER as a guarantee that after a Bid is accepted, Bidder will execute and file the Agreement and 100% Performance and Payment Bonds within 15 days after the Notice of Award.

Bidders shall comply with all provisions of Section 66.0903 of the Wisconsin Statutes with respect to wage scales.

The Village of New Glarus reserves the right to reject any or all Bids, to waive any technicality, and to accept any Bid which it deems advantageous. All Bids shall remain subject to acceptance for 85 days after the time set for receiving Bids.

Contract award shall be made based on the lowest responsive and responsible Bidder.
